## **RECEIPT OF BIDS**

The City of Eastpointe will receive electronic bid submittals <u>only</u> until 2:00 pm, local time on Thursday, June 23, 2022. All bidders must submit their proposal, all attachments, and any modifications or withdrawals electronically through BidNet. The bidder must submit copies of documents as a PDF. Bidder's failure to submit a proposal as required may result in disqualification. The proposal and attachments must be fully uploaded and submitted prior to the proposal deadline. Do not wait until the last minute to submit a proposal. BidNet will not allow a proposal to be submitted after the proposal deadline identified in the solicitation, even if a portion of the proposal has been updated. E-mailed bid submissions will NOT be accepted.

### **DESCRIPTION OF WORK**

This project consists of the replacement of water main along the following streets:

- 8 inch water main along Beechwood from Juliana to 9 Mile Road
- 18 inch water main along the west side of Gratiot Ave from 8 Mile Road to
   9 Mile Road

in addition to water service transfers, replacement of lead and galvanized water services from the water main to the water meter inside the home per EGLE's current Lead and Copper Rule, pavement, driveway and sidewalk restoration and sod restoration.

In addition, is the replacement of lead and galvanized water services located along Tuscany Avenue from Toepfer to 9 Mile Road.

# State and Federal Regulations

Not less than the minimum salaries and wages set forth in the Contract Documents must be paid for those locations.
